## letter from our president

## Hello, Furry Friends

Many of our teams are in need of additional volunteers, and several sites need captains. Having a captain is essential in order to for Furry Friends to do visits. Being a captain isn't hard, and it's very little additional work over and above doing your regular visit.

What's involved in being a captain?

- You will be the point of contact between the facility and Furry Friends; ideally, you'll check with the site prior to each month's visit, to ensure they're expecting us, and that there's no reason we \*shouldn't\* come (a flu or COVID outbreak, for example).
- Send a reminder email to the team prior to every visit.
- Send the visit attendance to our admin on a regular basis.

No training is required to be a captain, although we do hope to reschedule the captains training later this year.

We continue to get requests from new facilities who want us to visit, and new site requests remain on hold until we can resume visits at our existing sites. So please consider being a captain!

If you think you might be interested in helping in this way, please let us know! And consider coming to the Captains Dinner in April, to learn even more. Details on how to sign up are elsewhere in this newsletter.

Main Jail and Elmwood Correctional Facility Last summer, Furry Friends started doing monthly visits at the Santa Clara County Main Jail in San Jose and at Elmwood Correctional Facility.in Milpitas. Both visits are awesome, and additional volunteers are needed.

Visits at the Main Jail are on the 2nd Saturday of the month, at 9am. Visits take place in the infirmary units, with inmates who are interested in interacting with the dogs. We usually meet with one inmate at a time, under the watchful eye of the deputy escorting us. On our first visit, one of the men shared that he hadn't touched a dog in 13 years! The staff is also happy to see us, and get doggie snuggles; one of them thanked us for coming to visit this "forgotten population."

Visits at Elmwood are on the 3rd Thursday of the month, at 9am. Visits are often in outdoor recreation areas, or in dormitory-like settings with several inmates. Those visits too are under the watchful eyes of deputies escorting our volunteers. At the last Elmwood visit, one of the inmates said to the team captain, "Are they here to make us happy? Well, it's working."



Right now there are only 5 people who have the appropriate security clearance to do these visits. If someone goes on vacation or is sick, there is a very small pool of volunteers to pull from.

## JULIE BOND, M.S. ANIMAL BEHAVIORIST



Just as I did in the last two newsletters, I'm once again using my column to review some of the material covered in the etiquette class as many of you haven't attended one in several years and I'm always adding information to the class as our policies and procedures change/get updated over time. For those of you who have attended a recent etiquette class, this particular column will serve as just a gentle reminder of what we covered there. As always, if any of this isn't clear, or you have further questions, please let me know!

## **TOYS ON VISITS:**

Please don't bring toys on any leashed visits, including special visits. While I realize it might be tempting to bring a toy for the kids on the special visits to use to engage your dog, toys are only allowed on our off leash visits. Why? Because I test every animal at the off leash class evaluation for their non-reactiveness around toys, willingness to share toys, and their ability to drop any toy they have on command. Dogs in our regular programs and events are not tested extensively on these behaviors and may very well have issues in resource guarding that not only prohibit them from being on an off leash team, but would make another dog having a toy on a visit a risk for them to be exposed to, potentially triggering an aggressive episode.

## **RAW DIETS:**

Back in 2022, Furry Friends implemented a new policy with regard to raw diets. Following the guidelines established by the AVMA, and endorsed by the American College of Veterinary Nutrition, we have asked that all volunteers refrain from feeding their pets a raw diet as doing so can lead to the transmission of pathogens between pets and immunocompromised individuals. Here is the statement released by the AVMA:

"The AVMA discourages the feeding to cats and dogs of any animal-source protein that has not first been subjected to a process to eliminate pathogens because of the risk of illness to cats and dogs as well as humans. Cooking or pasteurization through the application of heat until the protein reaches an internal temperature adequate to destroy pathogenic organisms has been the traditional method used to eliminate pathogens in animal-source protein."

## **SKIN INFECTIONS:**

If your pet has a "hot spot," basically, a patch of moist dermatitis on their skin, you will want to refrain from attending visits until that patch of skin irritation characterized by an open, raw sore, has healed. The reason for this is that MRSA, Methicillin-Resistant Staphylococcus Aureus, a drug-resistant bacteria, is prevalent in most if not all hospital environments. MRSA can easily be transmitted from pets to people via open sores like hot spots. While MRSA will not make your dog sick, it can use that open sore on your dog as a way to move out of the hospital environment, potentially exposing other people in the community, including your family, to the bacteria.

## DOING PET THERAPY VISITS OUTSIDE OF FURRY FRIENDS:

While Furry Friends does not put restrictions on their members from being a part of other pet assisted therapy groups or organizations, if you are doing visits on your own, whether part of another group OR simply by yourself in the community, you must not misrepresent yourself on those visits as being a Furry Friends member. Our visits are always on specific days and times. Our insurance covers us for these sanctioned visits. If you are asked by a facility to come back with your pet and visit on your own on an additional day, that's great! Just make sure they understand that you'll be coming back on your own, without our insurance covering you for that visit. You will not wear your Furry Friends t-shirt, badge, or use your purple leash. If you are doing additional pet therapy visits on your own, you will want to check with your homeowner's insurance or renter's insurance to do so.

## SERVICE DOGS, THERAPY ANIMALS, & EMOTIONAL SUPPORT ANIMALS:

While the general public and the media often use these categories interchangeably, adding in new ones like comfort canines, there are important differences between animals used in each of these roles. We give every new volunteer a card in etiquette class that outlines the differences between service animals, pet therapy animals, and emotional support animals because we want to make sure all of our volunteers are educated on the differences and can go out into the communities we visit and make sure that others understand those differences as well. Service animals are afforded rights by the ADA, the Americans with Disabilities Act, to bring their animals into public establishments without restrictions. They can live with their owners in places that have no pets policies because their service animals are not pets, but medical equipment, required to aid them in the performance of specific tasks. Service animals go through extensive training so that they can tolerate a wide variety of situations and experiences reliably. While therapy animals and comfort canines go through some basic obedience training and evaluation for the activity of visiting patients for the express purpose of pet assisted therapy, they are not afforded any special privileges with regard to access to public spaces that don't already allow those animals on the premises. Emotional support animals are also afforded no special rights or allowances via the ADA. While basic manners are expected, they are not required of emotional support animals. People with emotional support animals cannot be discriminated against for housing, but their pets can be removed if they are disruptive, aggressive, etc. While it is possible for a service animal or an emotional support animal to also work as a pet assisted therapy animal, it is not, however, the case that every pet therapy animal is also a service animal or emotional support animal. And it goes without saying that vests, harnesses, ID cards, etc. are not accepted as the sole indication that an animal is trained as a service animal. There are simply too many fly-by-night companies and individuals out there turning a quick profit by "certifying" pets as service animals and emotional support animals when they have no business doing so. On more than one occasion, we've had prospective new volunteers come to etiquette class with the sole purpose of certifying their pets so they can "take them everywhere with them." We've had volunteers try to use their Furry Friends membership to get on airplanes, go into stores and buildings where only service animals are allowed, and onto school properties as "classroom pets." This is not what we do with Furry Friends. Anyone who attends etiquette class with that as their goal is immediately told that we don't do that, nor do we support anyone who intentionally misleads the public as to the role of their pet. Teachers who want to take their dogs into their classrooms, therapists who want their own pets helping with their patients, etc. are referred to organizations that evaluate individual animals for that type of work. Anyone who is caught misrepresenting their pet and using their Furry Friends membership to do so can and will be removed from the organization as that type of behavior puts us all at risk.

## MAKE YOUR VISITS WORK FOR YOU & YOUR PET:

If you are on a visit and your pet doesn't want to enter a room, balks at meeting someone, or displays any apprehension whatsoever with a person, situation, room, or event, STOP. Don't force your animal to engage someone they don't want to engage, go into a room they are resisting, etc. It simply isn't safe and you run the risk of something happening such as a growl, snap, or bite. You also run a greater risk of creating a situation where your pet dreads doing

visits and you have to discontinue pet therapy. If instead you watch your pet and listen to them, you reduce the risk of that happening. While I do test every animal coming into our organization for their behavior with a walker and a wheelchair, there are other kinds of medical equipment that may be off-putting for your pet. There are also different styles of walkers and wheelchairs and some may scare or startle your pet at first. Pets have a keener sense of smell than we do, so they may be avoiding interactions with someone they feel smells "scary," "different," or "ill/infirmed." If your pet resists meeting someone, you can downplay it by saying something like, "Oh, I guess he needs a break. We're going to head outside for a bathroom break and some water" and then do just that. Maybe they did need a break! If you come back to the visit and they are still trying to head for the door, just let your team captain know you are leaving and head home. Better to end a visit early than push your pet beyond their comfort level. I have certainly met some Furry Friends members whose pets don't like elderly people, act strangely around patients with memory deficits, or who don't like children. And, yes, they can still do pet therapy with our organization! We simply need to steer those volunteers and their pets toward the visits they will be most comfortable attending. We have lots of visit choices in our organization, so it isn't hard to find the perfect fit that's safe for all concerned.

## **Carrot Pupcakes**

PUPCAKES INGREDIENTS

- 1/2 CUP ORGANIC BUCKWHEAT FLOUR
- 1 E G G
- **1 TEASPOON BAKING POWDER**
- 1 TABLESPOON MANUKA HONEY
- 1/4 CUP ORGANIC COCONUT OIL
- 1/2 CUP COCONUT MILK OR WATER
- 1/2 CUP GRATED CARROT
- MINI CUPCAKE PAN
- ICING INGREDIENTS
- 50G YOGHURT DROPS
- 1 TABLESPOON COCONUT OIL
- CAROB DROPS (OPTIONAL)
- GRATED CARROT (OPTIONAL)

#### PUPCAKES DIRECTIONS

- PREHEAT OVEN TO 160°C
- IN A BOWL COMBINE BAKING POWDER AND HONEY AND MIX WELL
- ADD BUCKWHEAT FLOUR, COCONUT OIL, COCONUT MILK / WATER AND EGG TO BOWL
- MIX UNTIL WELL COMBINED
- ADD GRATED CARROT AND MIX THROUGH
- DIVIDE EVENLY INTO CUPCAKE PAN
- BAKE IN OVEN FOR 15 20 MINUTES

ICING DIRECTIONS

- MELT YOGHURT DROPS & COCONUT OIL OVER A LOW HEAT
- CAREFULLY DRIZZLE MELTED YOGHURT DROPS OVER PUPCAKES
- ADD YOUR OPTIONAL DECORATION TO TOP OF PUPCAKE BEFORE YOGHURT DROP SETS
